DEED OF GUARANTEE

To: CITY TIMBER LIMITED

In consideration of you at my request agreeing to supply and services from time to time for the purposes of its business I hereby:

("the Customer") with goods

1. Unconditionally guarantee to you the due and punctual payment by the Customer of all moneys as and when they shall become due and payable by the Customer to you in respect of the purchase price of the goods and the due observance and performance by the Customer of all its obligations in respect of any agreements between City Timber Limited and the Customer.
2. Agree that although my liability under this guarantee as between me and the Customer is as surety only, I shall be liable as a principal debtor to City Timber Limited and my liability will not be discharged, abrogated, prejudiced or affected by any of the following:
 - the granting of time, credit or any indulgence or other concession to the Customer;
 - by the release, abandonment, waiver, variation, establishment or relinquishment of any securities or any rights that you may have against the customer;
 - any alteration, modification, variation or addition to any agreement relating to the supply of goods or services or the relationship between City Timber Limited and the Customer;
 - any change in the shareholding or directorship of the Customer or the receivership or liquidation of the Customer;
 - any other act, event or omission which but for this clause might operate to discharge, impair or otherwise affect this guarantee and my obligations contained in this guarantee or any of the rights, powers or remedies conferred upon you by this guarantee or by law.
3. Agree that this guarantee shall be an irrevocable and continuing guarantee and shall remain in full force and effect until the Customer has paid you all moneys due in respect of the goods or under any agreement between City Timber Ltd and the Customer.
4. Agree to waive any rights of subrogation in respect of any security held by you in respect of the Customer's obligations to you until the Customer has paid all moneys due to you in respect of the goods and all other obligations under any agreement between City Timber Ltd and the Customer.
